Attached, for board approval, is a slate of nominees for election as National Council Delegates and Alternate National Council Delegates. The Board Development Committee used the following process in its work to develop a slate of national council delegates and alternate delegates.

- 1. National Council Delegates elected in 2005 from each of the four legacy councils were polled for their interest and eligibility to serve in 2008. Those who met eligibility requirements and who expressed a willing to serve were placed on the slate.
- 2. Alternate National Council Delegates elected in 2005 from each of the four legacy councils were polled for their interest and eligibility to serve in 2008. Those who met eligibility requirements and who were willing to serve were considered for placement on the slate to fill vacancies
- 3. Any positions that remained vacant were opened to any interested council member who met the eligibility requirements. A notice was sent to board members requesting a reply from those interested and, in addition, was communicated to members through the council website and service unit meetings, requesting a brief letter of interest and biographical sketch.
- 4. The Board Development Committee reviewed the letters of interest and placed interested members on the slate. An effort was made to maintain geographic representation. One girl member was selected from each of the four regions.

Because the nature of the National Council Meeting is to influence policy, board members of Girl Scouts of Western Ohio were given preference in placement as National Council Delegates.
