- 13. What would need to happen for you to attend an Annual Council Meeting?

 - The Buckeye Trails Region not be treated with contempt by the Great Rivers Region. In spite of what you may think, we are not spoiled. We just know what works for us.
 - I would need a ride
 - If we are unable to attend, if the web session could be taped and available to be viewed when we were able
 - Weekday evening time
 - I would attend if it were not for surgery. I am disappointed I can't attend. I am VERY interested in anything to do with our girls.
 - Terrific speaker with relevant information for girl development
 - Date/schedule balanced with commitments
 - The distance that the meeting is from my house is irrelevant to me. I do feel that if there were enrichment opportunities either before or after the meeting that newer volunteers would be more encouraged to attend. A lot of new volunteers don't understand what an Annual Council Meeting is if there was an opportunity for them to attend and take something back to do with their girls, I think they would be more inclined to come and, as a result, come more in the future.

- Advance notice. Worth my while.
- Have it fit into my busy schedule of work, school and three kids, etc.
- Perhaps a park and ride share from the regional office. Not every service unit has several people that can attend.

- To be informed of it in time to get the time off work, not every leader works a 9-5 job with weekends off
- Child care and transportation are issues during very challenging times

- Other than getting help from local advisors, I don't see a need for interaction with board members.
- Maybe have them attend a service unit meeting in our area to introduce themselves in person
- Have them come to my area, not the other way around
- Events where board members have the opportunity to visit with various groups
- Would love to personally meet them
- In every way imaginable
- Send out surveys on topics that we can give feedback like on camps and day camps, etc.
- Where are they, when and where do they meet? 90% of us have no interaction with anyone higher than our regional director, or what processes go on behind the curtain. I feel they are not accessible to the volunteers, or interested in what we think.
- I would like to have town hall meetings with them so that they can hear what we hear from leaders, parents, and girls.
- Presence at important meetings or events, access to email updates or addresses

- I think that Western Ohio should be dissolved or at the very least the regional headquarters moved to the Lima office. It is more centrally located and the people are nicer there. They don't seem to lose everything that I send to them. I am referring to my service unit day camp reservations. I had to submit them 3 times online before they were passed on to Lima. Give us back our regional camps. Funneling everything through Cincinnati is stupid and does not seem to be working very well.
- It never made sense to me to have an election of officers where everyone on the slate is elected...voting makes no difference.
- It will not make any difference in participating in the meeting due to the current method of governance. The board really has very little power.
- About questions 10-12, what is the difference between Not likely and Unlikely? I suppose there could be a technical difference, but this is not a technical questionnaire, is it?

- I think the program we are to be following at this time should have had more planning and thought time. We as leaders, are scrambling to figure out what we are supposed to be doing. It is a lot to take in for a program that is supposed to be easier. Those that are supposed to have the answers seem to be at a loss sometimes for our questions.
- You all are doing a great job. As an adult member for 55 years, I see the ways you are improving our program for the girls.
- I am a volunteer trainer and Daisy Girl Scout leader and trust that the board is acting in the best interest of the girls and of me as a volunteer.
- Thank you and keep up the good work for the good of the girls!
- I think that council members in general should be in face to face contact with leaders and service units. How else will they know what we are doing and dealing with.
- Additional members from BT region
- Keep Girl Scouting active in the entire geographic area leaders active at merge are not real positive 2 years later especially today when Girl Scouting is needed in so many girls' lives
- Since the merger we have lost most of our staff and feel nothing we do makes an impact on anything above service unit level

- Re-open Camp Greene in Yellow Springs!
- Not at this time. Thanks for all you do!
- I would like to know if we could please bank somewhere in my home town such as Fifth Third, having to drive 30+ miles to deposit cookie money is not good. Also I want our local Girl Scout camp re-opened. Dearborn County Indiana has a grant program, write for a grant and re-open our camp. Another thing I believe that BSA wants to see the Camp Luie Ernst in Madison used more often and girls can use the site. This should be public knowledge. As a leader we want to take our girls camping and have a local summer camp experience.
- Please work to see that GSWO properties are being fully funded to develop income stream and keep and protect every one of them for current/future generations of Girl Scouts
- Re-open day camps

- Am wondering in Buckeye Trails office is going to continue to operate...seems like I am finding more and more I am interacting with staff from Great Rivers...
- People who run our council watch Undercover Boss and learn some lessons from that show, everyone could learn something new and useful. Our open door policy is truly not an open door, it is a swinging door that if opened to fast can bounce back and smack you in the face or rear depending on your direction of travel. As a reminder of the endless circle, volunteers can not do their jobs accurately without the proper tools which we are supposed to get from GSWO, but in turn without us volunteers, paid staff and board of directors would not have jobs at all, it truly takes all of us "working" together and valuing each and every opinion we can gather on a subject "before" a decision is made. Volunteer's opinions do not seem to make a difference so most keep them to themselves, but those raised the Girl Scout way have the courage to speak of their issues/opinions and are scrutinized, and or punished for making the opinions public.
- I understand the difficult in providing resources in a time of economic difficulty however, I feel that my region has had many resources pulled from it (it was not what was promised when we merged) and we have less this is also the consensus of my leaders in the service unit. Everything appears to be in Cincinnati and we do not seem to have a voice in Cincinnati. Our Council employees are doing an awesome job with less all of the time. They do not complain and are extremely supportive of the structure and of the merger these are observations from leaders, service unit managers, parents, etc.
- I am concerned about the lack of communication with older adult members, (many life) who are not online. They have given many years to Girl Scouts as volunteers and are now ignored. These are volunteers who are most likely to support the council financially, if not presently, after their death.
- Keep in mind that in today's society, girls are able to be involved in so many other activities (4-H, sports, church groups, FFA for older girls, other extracurricular clubs, etc.) that in the past weren't always open to them. Their attentions (and those of their parents) aren't always toward Girl Scouts, especially as they get older. It will be important to have Girl Scouts provide a program that will hold the girls interest and be affordable for the parents in this tough economy.
