Subject: 2020 National Council Session Results

The National Council is the membership body charged with giving broad policy direction to the future of the Girl Scout Movement in the United States. The National Council's responsibilities, eligibility requirements, composition, size, and how and when its meetings are held is outlined in the Congressional Charter and the Constitution of Girl Scouts of the United States of America, as found in the *Blue Book of Basic Documents*.

Girl Scouts of Western Ohio has 26 delegates and 19 alternate delegates. The National Council Session took place October 23-25, 2020 by electronic means. Our delegation had been hard at work, attending training sessions, listening sessions, and webinars to prepare for the deliberations. Delegates came to the deliberations informed, but not instructed. They each voted, based on their own views; however, we sought to ensure that delegates understood the implications of votes for and against the proposals.

There are six proposals before the National Council for deliberation and decisions. The following is a summary of each proposal:

- <u>Proposal 1: Establishment of a Task Force to Examine the Feasibility of a National Gold Award</u> <u>Scholarship Foundation</u> – originated by Girl Scouts of Greater Chicago and Northwest Indiana. This proposal requested that the National Council establish a task group, charged with examining the feasibility of developing a college scholarship foundation to benefit Gold Award Girl Scouts. The task group will report back on the feasibility, recommendation, and timeline for potential establishment of the foundation by the 2023 National Council Session. This proposal was approved.
- **Proposal 2: Constitutional Amendment on Membership Dues** originated by the National Board, on recommendation of the National Council Session Advisory Team and Dues Subgroup. This proposal sought to amend the Constitution to clarify that membership dues are set by the National Council or the National Board. It further stated that the National Board shall implement procedures for communicating with and seeking input from Girl Scout councils and National Council delegates prior to any membership dues change by the National Council. This proposal was approved.
- **Proposal 3: Adoption of a Procedure for Communication on Dues Actions by the National Board** originated by the National Board, on recommendation of the National Council Session Advisory Team and Dues Subgroup. This proposal mandated that, prior to any vote of the National Board to change membership dues structure or amount, Girl Scouts of the USA shall communicate with and seek input from local Girl Scout councils and National Council delegates on the proposed changes, intended use of the funds, and potential impact on the Girl Scout Movement. This proposal was approved.

- **Proposal 4: Membership Dues Increase Restriction** originated by Girl Scouts of Greater Chicago and Northwest Indiana. This proposal sought to amend the current procedures to mandate that the National Board must seek approval from the National Council whenever a planned dues increase will result in dues increasing more than a total of 25% in any one triennium. The council brought this proposal forward because they believe that this will affirm that any increase would not prove to be too burdensome on the members, families, and councils. This proposal was approved.
- **Proposal 5: Constitutional Amendment on Consistency in Delegate Terms** originated by Girl Scouts of Central and Southern New Jersey and Girl Scouts of Southeastern New England. This proposal suggested that delegates should be elected in the second year of the triennium, in the year preceding the National Council Session. Currently, most council elect delegates in the third year of the triennium, so they only have about six months to be engaged in the process before the National Council Session. This proposal was approved.
- **Proposal 6: Lifetime Membership Discounts** originated by Girl Scouts of Connecticut. This proposal allows for discounted lifetime membership dues of \$200 to be offered to anyone who is a registered member and has served as a volunteer for a period of ten or more years. The council that brought this proposal forward believed that this recognizes the continued support and commitment to the Girl Scout Movement that such long-term volunteers have shown and encourage volunteer retention. This proposal was approved.
