Girl Scouts of Utah is seeking support for an amendment to the Girl Scout Constitution at the National Convention in 2014. The specific proposal, analysis and supporting documents are attached. Essentially, the amendment would require councils to appoint girl delegates to attend the National Convention.

As our Constitution is written now, councils are not required to have any girl involvement in the convention, even though our organization espouses it is girlled. Girl Scouts of Utah has had girl representation on our delegation the past three conventions with much success; we've found their perspective and energy to be refreshing and enlightening. As we plan for the National Convention to be held in Salt Lake in 2014, these girls have been completely invested and will be fulfilling important roles in the execution of the convention.

By giving girls the opportunity to compete for these positions, we believe this amendment will have the ancillary effect of increasing older-girl involvement and membership. The proposal would also give girls real-world advocacy experience that would be impressive on resumes and college applications. Most importantly, the amendment solidifies that Girl Scouts is truly an organization which is girl-led, believes in learning by doing and promotes cooperative learning.

Girl Scout of Utah is excited to propose this amendment and would like your input and support leading up to, and during the National Convention. If you'd like more information, please feel free to contact me. I'm happy to discuss the background and any reservations your council may have. If you support the concept of this proposal, I'm asking you to complete the "Support of Proposal" form, included in this packet by September 13, to be included in our official submission.

To Whom It May Concern,

My name is Vanessa. I am seventeen years old, and I have been a Girl Scout for nine years. As an older Girl Scout, I have had many incredible experiences, including my participation in the National Convention in Houston, Texas, as an alternate delegate. My council, Girl Scouts of Utah, took eight people to attend the National Business Meetings. Of these eight people, five were girls. The girls from my council and I were shocked at the low representation of girls from other councils. Personally, I find it sad that so few girls were given an experience that I learned so much from.

I applied to be a national delegate over a year before I attended the National Convention. I was selected as an alternate, and I promised to attend National Convention in November 2011. This taught me commitment. Soon after I was selected as an alternate delegate, my council began training everyone who would attend. We learned parliamentary procedure, political process, and the specifics of what we would be voting on. We held town meetings, where we spoke to the members of our council about the proposals and listened to their feedback. This taught me not only the political process, but also what it means to represent other people. When the girls from my council arrived at the National Business Meetings, we were prepared. This reinforced the idea that practice makes perfect. In the meetings themselves, I learned more about the political process and parliamentary procedure, and I was given an enriching experience that allowed me to collaborate with adults, but to have my own voice in an organization that I love.

These are the kinds of experiences that build girls of courage, confidence, and character that make the world a better place. Earlier this summer, I attended Girls' State; I used what I learned through this experience to participate fully and to earn a place in our mock House of Representatives. I am looking forward to my AP Government and Politics class next year in school, and I am excited to register to vote as soon as I can. I am also working to change the politics of Girl Scouts with this amendment. Clearly my experience at National Convention has impacted me. Imagine what it can do for other girls.

AMENDMENT TO MANDATE GIRL DELEGATE POSITIONS

Statement of Proposal:

To amend the Constitution of Girl Scouts of the USA, Article IV (The National Council), Section 5 (Formula for Delegates), by inserting after the first paragraph, as follows:

Each local council to which a charter has been issued and remains in force shall be entitled to the following delegates based on the number of girls under its jurisdiction who are members of the Girl Scouts of the United States of America as of September 30 of the year preceding the regular session of the National Council: a. two (2) delegates; b. one (1) additional delegate for up to 3,500 girls; c. one (1) additional delegate for every 3,500 girls thereafter. USA Girl Scouts Overseas collectively shall be entitled to the number of delegates according to the same formula prescribed for local councils. The prescribed figure of 3,500 girls may be adjusted when necessary to keep the total membership of the National Council no larger than 1,500. 
Rational of Originating Council:

Inherently, girls should be at the helm of the organization to guide and influence the policies and procedures of the Girl Scout Movement. This amendment requires a council with more than 14,000 members to devote a proportion of their delegate positions to girls between 14 and 17 years old. Well-trained girl members of a delegation should be able to make voting decisions as capably as adult members. More importantly, girls have the drive, ability and ambition to help guide the Girl Scout Movement and should be given the opportunity to do so.

One criterion for a council in the Blue Book of Basic Documents is, "actively seeks to strengthen the stakeholder involvement and interaction to ensure that the membership is involved in influencing major policy decisions and helping to set strategic direction." What better way to comply with this directive than to see our most important stakeholders – girls—in leadership positions, helping to guide the Girl Scout Movement as delegates at the National Convention?

This amendment requires a council with more than 14,000 members to devote a proportion of their delegate positions to girls between 14 and 17 years old. Well-trained girl members of a delegation should be able to make voting decisions as capably as adult members. More importantly, girls have the drive, ability and ambition to help guide the Girl Scout Movement and should be given the opportunity to do so.

One criterion for a council in the Blue Book of Basic Documents is, "actively seeks to strengthen the stakeholder involvement and interaction to ensure that the membership is involved in influencing major policy decisions and helping to set strategic direction." What better way to comply with this directive than to see our most important stakeholders – girls—in leadership positions, helping to guide the Girl Scout Movement as delegates at the National Convention?
